SUBJECT: DoD Financial Management (FM) Related Professional Certifications and DoD Civilian Reimbursement for Associated Expenses

Title 5, United States Code, Section 5757 permits agencies to use appropriated funds, or funds otherwise available, to reimburse competitive service civilian employees for costs associated with obtaining FM-related professional credentials. This memorandum adds the Certified Public Finance Officer (CPFO) and Certified Inspector General Auditor (CIGA) to the list of FM-related test-based certifications approved for expense reimbursement, bringing the total number to 22 (Atch A).

Expense reimbursement is subject to authorized expenses and the availability of funds. Components assume responsibility for providing the reimbursement effective with Fiscal Year 2018. Components shall make funds available to reimburse employees for test fees, test registration fees, license/certification application or issuance fees, and license/certification renewal fees for obtaining and maintaining any of the 22 approved test-based certifications. Components shall also reimburse employees for professional society membership fees, only when membership is inseparable from certification. Agencies may reimburse employees for other professional certification costs subject to agency policy.
