### **Accessibility**

To make it easier for personnel to attend and control travel expenses, this course is offered at a variety of locations worldwide throughout the year.

## Centrally-Funded Courses

Centrally-funded courses are provided by the Department of Defense but are licensed and copyrighted by the American Society of Military Comptrollers.

#### **Overflow Courses**

ASMC offers overflow EDFMT courses for those who are not eligible for a centrally-funded course. The materials and instruction are the same as the centrally-funded courses. ASMC has licensed vendors to conduct both open enrollment courses and courses purchased by an organization, company, or ASMC Chapter. Open enrollment courses are listed on the ASMC website.


For those who wish to purchase the course for their organization, company, or ASMC Chapter, please contact ASMC Headquarters at certification@asmconline.org for information.

The following is a list of requirements for the hosting organization.

- Point of contact's name and phone number at each training location
- Training facility address, including classroom number, and shipping address for materials
- Directions to each training location (including a map)

- List of hotel recommendations at each training location
- Student roster and instructor name provided to building security to allow easy access to classroom
- Computer with CD-ROM driver and LCD with PowerPoint software loaded (recommended)

- Overhead projector and screen
- Two flip charts and stands (including markers)
- Classroom set up per room configuration prescribed by training vendor

#### What is the EDFMTC?

The Enhanced Defense Financial Management Training Course (EDFMTC) is a five-day, 40-hour, intensive financial management review course.

There are no prerequisites established by ASMC for this course, only selection by the Department of Defense to attend (for those taking a centrally-funded course). Overflow courses are available to anyone who is not approved for centrally-funded courses.

The course is delivered in a classroom setting with two instructors and up to 32 students.

While presented in an "overview" format, the material covered in the course varies in intensity from the intermediate level to the advanced level. The course is presented in 3 sections that correspond to the CDFM exam modules and knowledge areas:

Mod 1 - Resource Management Environment | Mod 2 - Budget & Cost Analysis | Mod 3 - Accounting & Finance

### Why the EDFMTC?

Attendees who complete the course can earn credit toward DoD FM Certification.

The training is recommended for and benefits DoD financial managers in a variety of ways:

- The departmental leadership is interested in improving the overall technical and managerial capabilities of the financial management work force.
- The program is designed to broaden the perspective of financial managers by introducing them to areas of expertise outside their daily responsibilities.

This service enables adult learners to present a nationally recognized transcript to the college or university of their choice for the potential award of academic credit. ACE CREDIT recommends the EDFMTC for 3 credit hours at the lower-level baccalaureate degree category for students who earn a C or higher in the course. For upper-level baccalaureate credit, a written paper must be submitted in addition to completing the course with a B or higher for consideration of 3 credit hours.
